Prof. Arun K Rath, Retired Civil Servant, Government of India.

Prof. Arun K. Rath, Master of Science in Physics and Doctorate in Business Administration, joined the Indian Administrative Service in 1973. During three decades of his career in the civil service, Dr. Rath contributed to government and to the corporate world. Dr. Liu Yuan, State-owned Assets Supervision and Administration Commission of the State Council (SASAC), China


Dr. Liu Yuan, born in 1964, graduated from Renmin University of China in 1992 from where he also completed his PhD in Economics.
