1. In pursuance of the decision in the meeting held on 27.6.2016 in PMO, DPE has issed guidelines on "Time bound Closure of Sick/ Loss making Central Public Sector Enterprises (CPSEs) and disposal of their movable and immovable assets" on 07.09.2016 to the administrative Ministries/ Departments to take necessary action in respect of CPSEs under their administrative control. This would facilitate the administrative Ministries/ Departments for time bound closure of CPSEs and for disposal of the movable and immovable assets.

2. During the month of August, 2016 DPE examined 6 CCEA/ Cabinet Note and 5 Inter Ministerial Group (IMG) Meetings were attended. Guidelines on closure on sick CPSEs have been issued on 07.09.2016.

3. IMC was constituted as an alternative system to the Task Force for MoU 2016-17. IMC has finalized targets in respect of 234 CPSEs and exempted 143 CPSEs for the year 2016-17 by holding 518 meetings.

4. DPE submitted information for CAPEX of select CPSEs to PMO on 8<sup>th</sup> September, 2016.

5. A workshop on capacity building on MoU has been held at Jammu on 28<sup>th</sup> September, 2016.

6. DPE organized the following two training programmes for the executives of CPSEs and SLPEs:-

- a) A 5 days residential training programme on "Leadership and other Enablers for achieving Business Excellence" at Delhi during the period 5<sup>th</sup> to 9<sup>th</sup> September 2016 in association with Indian Institute of Public Administration, Delhi. The training programme was attended by 40 executives of CPSEs and SLPEs.
- b) Another, 5 days residential training programme on "Production Plannning, Inventory Control and Supply Chain Management" at Guwahati during the period 19<sup>th</sup> to 23<sup>rd</sup> September 2016 in association with Indian Institute of Technology, Guwahati. The training programme was attended by 37 executives of CPSEs and SLPEs.

7. DPE organized a workshop on "Recent Changes in Companies Act, 2013 – IFRS" on 9<sup>th</sup> September, 2016 at Hyderabad in association with Institute of Chartered Accountants of India for the executive of CPSEs and SLPEs from the States of Karnataka, Telangana and Andhra Pradesh in which 43 executives have participated.

8. MoU has been signed on 29<sup>th</sup> September 2016 between National Skill Development Fund (NSDF), National Skill Development Corporation (NSDC) and Department of Public Enterprises (DPE) for implementation of Counselling, Retraining and Redeployment Scheme during the year 2016-17 for imparting skill development training to VRS/VSS optees/ their dependents through empanelled training providers.

9. Meetings of  $3^{rd}$  Pay Revision Committee (PRC) were held in Pune, Goa and Mumbai during 17-21 September 2016. 20 CPSEs/Associations made their submissions/ presentations before the  $3^{rd}$  PRC. Meetings of  $3^{rd}$  PRC were held during  $29^{th}$ ,  $30^{th}$  September and  $1^{st}$  October, 2016 at Kolkata.

10. A meeting of Search Committee was held on 7.09.2016 to consider the proposals for appointment of non-official Directors on the Boards of following CPSEs,
