Department of Public Enterprises Monthly Achievements – May, 2017

1. Department of Public Enterprises organized the first 3day CSR Fair in association with ONGC Ltd and PHD Chamber of Commerce and Industry from 4th to 6th May, 2017 at Pragati Maidan, New Delhi to showcase CSR achievements of CPSEs. The Fair was inaugurated by Minister (HI&PE). Hon'ble In total organizations, which included 81 Maharatna, Navratna and Miniratna and other CSR eligible CPSEs, Central 34 NGOs/ implementing agencies Ministries and participated in the Fair. Besides, 8 seminars on various themes viz. 'CSR- the Game Changer in Sports'; 'CSR as Prime Engine for Swachh Bharat'; 'Incubation of New Technology through CSR'; 'CSR as a driver for Skill Development and for providing livelihoods'; CSR in providing quality Pre-school, School and Higher Technical and Vocational Education'; `CSR furthering the Social Justice and Welfare Agenda'; 'Leveraging CSR for Conservation & Restoration of Cultural Heritage' and 'Scope and opportunities for Health & Nutrition Initiatives in the CSR space' relating to CSR were organized during the Fair. These seminars were addressed by eminent speakers/Secretaries to Govt. of India.

In addition, CMDs & Directors of different Maharatna, Navratna and Minirtana CPSEs, Professors of IITs, renowned national players like Shri P. Gopichand (Badminton); Ms. Mary Kom (Boxing); Shri Somdev Devvaran (Lown Tennis); Shri Khazan Singh (Swimming); Ms. Karnam Malleswari (Weight-lifting); Shri Bhaichung Bhutia (Football) also addressed in the Seminars.

- 2. A two days orientation programme was organized on 29th and 30th May, 2017 at Dehradun for capacity building of 16 newly appointed non-official Directors of CPSEs. The participating Directors were sensitized about their role and responsibilities in the context of newly enacted Companies Act, 2013 and other important related issues such as CSR, Strategy, Internal Control Mechanisms, etc. to facilitate better functioning of the Boards.
- 3. Meetings were held in May 2017 with the CPSEs and the concerned administrative Ministries/Departments having cash and bank balance of more than Rs.1000 crore to review the progress made by them on utilization of surplus cash in the light of DIPAM guidelines on Capital Restructuring of CPSEs issued vide OM dated 27.5.2016. The report is being sent to PMO.
- 4. Awards in the matter of Arbitration between M/S Dredging Corporation of India Limited (DCIL) and M/S Kolkata Port Trust (KPT) relating to non-payment of bills and between M/S National Fertilizers Limited (NFL) and Central Coalfields Limited (CCL) on account of under loading charges have been made on 2nd May, 2017 & 30th May, 2017 respectively.
- 5. A presentation was made by DPE before the Committee of Secretaries (CoS) in the meeting held on 12.05.2017 to discuss the recommendations of 3rd Pay Revision Committee, regarding review of pay scales of executives of CPSEs.

- 6. Under the MoU exercises, IMC finalized MoU 2017-18 targets in respect of 128 CPSEs (47 CPSEs up to previous month).
- 7. DPE has submitted information for CAPEX of select CPSEs to PMO on 11th May, 2017.
- 8. Four CCEA/Cabinet/SFC/PIB Notes have been examined and comments offered thereon. 15 IMG meetings have been attended during the Month of May, 2017.
- 9. The training calendar for programmes to be conducted for the financial year 2017-18 under RDC scheme of DPE has been circulated to all CPSEs/SLPEs. A DO letter has been sent to all Secretaries for updating the list of CPSEs under their administrative control for incorporation in the PE Survey 2016-17.
