### GLOSSARY OF CERTAIN TERMS USED IN THIS REPORT

1. **Capital Employed** means Gross Block of fixed assets less Accumulated Depreciation plus Working Capital.
2. Working Capital means all current assets, loans and advances less current liabilities and provisions excluding cash credits and bank overdrafts.
3. Investment (Financial) means paid-up capital, share application money pending allotment and long term loans.
5. Gross Block represents original cost of procuring and erecting fixed assets as appearing in the annual accounts of the CPSEs at the end of the accounting year and takes into account additions thereto and deduction there from by way of sales and transfers.
6. Gross Sales represents the total turnover and includes elements of excise duty, commission and discounts, etc.
7. Turnover/Operating Income means the aggregate amount for which sales are affected by the company including excise duty and receipts from operations/services rendered.
8. Cost of Production means all costs incurred on production/operation including depreciation and interest charges but excluding excise duty, Extra-ordinary Items and Prior Period Adjustments.
9. Net Worth means paid-up capital, share application money pending allotment and reserves less accumulated losses and Deferred Revenue Expenditure not written off.
10. Net Value Addition consists of Net Profit (PBTEP), indirect taxes and duties (net of subsidies), interest payment, royalty/rent/cess and salary and wages.
11. Cost of Sales means Cost of Production +/- depletion/accretion in stock of finished goods and Work-in-progress.
12. Profit before depreciation, interest, taxes and EP (PBDITEP)/Gross Margin: This represents excess of income over expenditure before providing for depreciation, interest on loans, taxes, extra ordinary items, prior period adjustments and appropriations to reserves.
13. Profit before interest, taxes and EP (PBITEP)/Gross Profit means excess of income over expenditure before providing for interest, taxes, extra ordinary items, prior period adjustments and appropriations to reserves.
14. Profit before taxes and EP (PBTEP) means excess of income over expenditure before providing for taxes, extra ordinary items, prior period adjustments and appropriations to reserves.
15. Profit before EP (PBEP) means excess of income over expenditure after providing for depreciation, interest, taxes but before providing for extra ordinary items, prior period adjustments and appropriations to reserves.
16. Net Profit means excess of income over expenditure after providing for depreciation, interest, taxes, extra ordinary items, prior period adjustments but before providing appropriations to reserves.
17. Net Loss means excess of expenditure (including depreciation, interest, taxes, extra ordinary items, prior period adjustments but before providing appropriations to reserves) over operating income.
18. Incremental Capital Output Ratio (ICOR):  $(\text{Capital employed} - \text{previous year capital employed}) / (\text{Value of production} - \text{previous year value of production})$ .
19. Return on Equity: It has been computed by deducting dividend on preference shares from Net Profit and divided by Net Worth as adjusted by the amount of preference share capital.
20. Market Capitalization: It is computed by multiplying outstanding equity shares at the end of the year multiplied by closing market price on Mumbai Stock Exchange. If closing price at the end of financial year is not available, the closing price on the latest available date has been taken for computation of market capitalization.
21. Earning Per Share: It is computed by dividing Net profit with paid-up capital and multiplying it by face value of each share i.e. Rs. 10/-. For the purpose of uniformity and comparability face value of equity shares of each CPSEs has been assumed at Rs. 10/- per share.
