## OFFICE MEMORANDUM

Sub: Modification of instructions to provide that the 50 per cent limit shall apply to current as well backlog vacancies and discontinuation of the Special Recruitment Drives.

The undersigned is directed to invite reference to the instructions contained in this Department O.M. No.36012/6/88-Estt.(SCT). dated April 25, 1989, according to which, for the purpose of determining the ceiling of 50 per cent on reservation, reservation against the current vacancies and the backlog vacancies are to be treated as two distinct groups. It was also laid down that the instructions; to the effect that not more than 50 per cent of the vacancies could be reserved for SCs/STs, Physically Handicapped etc, would apply only in respect of current vacancies arising in a year and would not apply in case of backlog vacancies reserved for SCs/STs, which would continue to be filled up without any restriction.

- 2. The Supreme Court in the judgement in the case of Indira Sawhney Vs. Union of India, inter-alia, validated the "carry forward" rule under which reservation are carried forward from year to year. However, while doing so, the Court also directed that the application of this rule, in whatever manner it was operated, should not result in the breach of the 50 per cent rule. In other words, the judgement laid down that the number of vacancies to be filled on the basis of reservation in a year, including carried forward reservation, should in no case exceed the 50 per cent limit. It is, therefore, not possible now to treat the current and the backlog reservation on separate footings, in the manner contemplated in this Department's O.M. dated April 25, 1989 mentioned in paral above.
- 3. In view of the position stated above, for the purpose of applying the rule of 50 per cent, a year has to be taken as the unit and not the
