The undersigned is directed to invite reference to MHA's OM No.8/2/69-SCT(I) dated 1.10.74, OM No.17016/1/76-SCT(I) dated 8.4.76 and Department of Personnel & Training OM No.36012/25/92-Estt.(SCT) dated 1.9.92 and to reiterate that Scheduled Caste and Scheduled Tribes employees may be permitted to write to the National Commission for Scheduled Castes and Scheduled Tribes direct on matters relating to appointment against the reserved quota. It is not necessary for Scheduled Castes/Scheduled Tribes Govt, employees to seek prior permission of the concerned administrative Ministries/Department for sending permission to the National Commission for Scheduled Castes and Scheduled Tribes.

All Ministries/Departments may please issue appropriate instructions to their subordinate formations. They may also apprise Scheduled Caste/Scheduled Tribe employees of the above information.
