OFFICE MEMORANDUM

SUB: Reservation for the physically handicapped persons in Group A, B, C & D identified posts/services under the Central Government—revised procedure for filling up of the vacancies.

The undersigned is directed to refer to this Department's OM No.36035/16/91-Es1t. (SCT) dated 20.9.94 on the subject mentioned above and to say that in para 2 of this OM, it has been stressed on all recruiting agencies that the vacancies reserved for the physically handicapped should be indicated along with the other vacancies, so that the physically handicapped candidates can also apply alongwith others.

- 2. It has been brought to the notice of this Department that while advertising the vacancies meant for persons with disabilities, the recruiting agencies are not indicating the sub-category of disability, for which the vacancies have been reserved. Further, the members of the general public may not be aware of the exact percentage of disability for being eligible for government jobs. As the Ministry of Agriculture, etc. are aware that with the enactment of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, the definition of categories of persons with disabilities for the purpose of reservation in posts/services under the Central Government was circulated vide this Department's OM No.36035/2/98-Estt. (Res) dated 4.6.1998. In this OM the minimum degree of disability for being eligible for getting employment under the Central Government has also been indicated.
- It has now been decided that while inviting applications for filling up of vacancies meant for persons with disabilities; the following information in the notice inviting applications should be invariably indicated:

 Sub-categories of disability for which the vacancies are reserved;

> (ii) the exact percentage of disability for being eligible for applying for the vacancy proposed to be filled up.

Further, there should be a column in the application form stating the category to which the candidate applying under the quota reserved for persons with disabilities belongs to viz SC/ST OBC/General.

3. All the Administrative Ministries/Departments etc. are requested to bring the above instructions to the notice of all the heads of Departments and appointing agencies under their control for necessary compliance.
