OFFICE MEMORANDUM

SUB: Clarification as to whether 3 per cent reservation for persons with disabilities would be with reference to identified posts only or to the total sanctioned strength in the cadre.

The undersigned is directed to invite a reference to this Department's OM No. 36035/17/85-Estt. (SCT) dated 1.4.1986, according to which 3 per cent of the vacancies are required to be reserved for physically handicapped persons in Group C & D posts with reference to total strength of the cadre. However, according to the instructions contained in this Department's OM No.36035/16/91-Estt. (SCT) dated 18.2.1997, 3 per cent of the vacancies are required to be reserved for persons with disabilities in Group A & B posts with reference to the identified posts in a cadre.

- 2. A question has been raised as to whether the percentage of vacancies not less than 3 are required to be reserved for persons or class of persons with reference to the total strength of the establishment in each Ministry/Department/Office or only in the posts identified for each disability, subject of course to the exemption of any establishment from the provisions of the Act, if felt necessary.
- 3. The matter has been examined in consultation with the Ministry of Law, Department of Legal Affairs. In accordance with the clarification given by that Ministry, 3 per cent of the vacancies would continue to be reserved for persons or class of persons with disability with reference to total strength of the cadre in Group C & D posts as per the instructions issued vide this Department's OM No.36035/17/85-Estt. (SCT) dated 1.4.86, keeping in view the provisions of the Section 72 of the PWD Act. However, in so far as Group A & B posts are concerned, 3 per cent reservation as laid down in terms of this Department's OM No.36035/16/91-Estt. (SCT) dated 18.2.1997 which were issued after the provisions of
