Thereafter, DPE analyses the performance of CPSEs as against the targets set for such respective CPSEs in MoU ,calculate MoU scores/ratings and put up the proposals before the ATF for their final consideration and recommendation which is finally approved approved by HPC. 3.	Finalisation of action plan, approval of new agencies/ EACs, approval of physical and financial targets and release of funds to nodal agencies under CRR scheme.	No. of maximum days taken from the date of approval of the action plan to date of communication to the nodal agencies regarding physical targets and release of funds.	90 Days
4.	Subsequent release of funds to nodal agencies under CRR Scheme- Further release of funds only after assessing utilization of funds released earlier and ascertaining physical performance.	No. of maximum days taken from the date of assessing utilization of funds by nodal agencies to date of subsequent release of funds to nodal agencies.	60 Days
5.	Forwarding proposal for selection of Non-official Directors by Search Committee / Public Enterprises Selection Board (PESB)	No. of maximum days taken from the date of receipt of complete proposals to the date of processing.	35 Days
6.	Conveying the recommendations of Search Committee/PESB regarding selection of Non-official Directors	No. of maximum days taken from the date of Search Committee meeting to the date of communication of recommendation of Search Committee to administrative Ministries.	35 Days
