Dear Sir,

The Government e Marketplace (GeM) has been set up as the National Public Procurement portal for offering end to end solutions for all the procurement needs of Central and State Government organizations. Since its commencement on 9th August 2016, GeM has transformed public procurement in the country by leveraging technology and making procurement contactless, paperless, and cashless.

Under Rule 149 of GFR, procurement of goods and services by Ministries or Departments is mandatory for goods and services available on GeM. The Department of Public Enterprises vide OM no. DPE-GM-12/0003/2016-GM-FTS-5670 dated 05.11.2018, had requested all administrative ministries to intimate CPSEs under their control to mandatorily come onboard on the GeM portal. In the review meeting of the Committee of Secretaries on GeM held on 24/10/2019 under the Chairmanship of the Cabinet Secretary, it was decided that Ministries and Departments may consider issuing advisories to CPSUs under their administrative control to procure through GeM wherever goods and services of required specifications and quality are available on the platform. It was also decided that the Administrative Departments/ Ministries may also monitor progress in this regard on a regular basis. It was further decided that IFAs of the Ministries and Departments may regularly monitor any delay or default in payment to agencies.

On its part, GeM has been interacting with Departments/Ministries and CPSEs to understand their requirements and the specific needs of products and services to make the procurement process seamless and user-friendly.

GeM has recently launched a nationwide outreach program 'GeM-Samvaad' to interact with buyers and sellers across the country. The Program commenced on 19th December 2019 and shall continue till 17th February 2020. As part of 'GeM-Samvaad', Secretary, Department of Commerce, Government of India, and Chairman, GeM, has kindly consented to chair a 'Roundtable with Ministries and Central Public Sector Enterprises (CPSEs)' on 14th January 2020.


In view of the above, you are requested kindly to nominate the Nodal Officer for GeM in the Ministry and the Financial Advisor to attend the Roundtable.






