Monthly achievements of DPE for the month of February, 2019

- 1. Pursuant to the recommendations of CoS on 31.12.2018 regarding review of the status of sick/loss making CPSEs under closure, DPE has collected updated information and has submitted the requisite CoS Note to the Cabinet Secretariat on 19.02.2019. Further, as per the recommendation of CoS, DPE in consultation with D/o Expenditure has issued a clarification relating to provisioning of MAT in the proposals for closure of CPSEs involving writing off of outstanding Government loans (and accrued interest thereon) vide OM dated 12.02.2019.
- 2. DPE has issued OMs dated 25.01.2019 and 01.02.2019 regarding Reservation for Economically Weaker Sections (EWSs) for posts in Central Public Sector Enterprises (CPSEs).
- 3. DPE organised a One-day Workshop on "Scalable Best Practices-Learning from the field" on 6th February, 2019 at Mumbai in association with IIT Bombay. The workshop was attended by 38 CPSE executives from 25 CPSEs. In addition District Collectors from different districts including aspirational districts, NGOs and Start-ups also joined the deliberations so as to ensure proper coordination in implementation of CSR activities.
- 4. DPE organised a two day orientation programme on 17th and 18th February, 2019 at Guwahati, Assam for capacity building of Non-official Directors of CPSEs. 72 Non-official Directors of various CPSEs attended the programme. The Participating Directors were sensitized about their role and responsibilities in the context of newly enacted Companies Act, 2013 and other important related issues such as CSR Committee, Audit Committee, Understanding Financial Statements, etc., to facilitate better functioning of the Boards.
- 5. DPE organised a meeting/Video Conference with the CSR Heads from select CPSEs on 14th February, 2019 in order to review the progress in the implementation of CSR projects/activities in aspirational districts during the current financial year.
- 6. DPE issued an OM on 14.02.2019 regarding Appointment of Security Personnel in Central Public Sector Enterprises (CPSEs) from Exservicemen Security Agencies sponsored by the Directorate General of Resettlement (DGR) after discussions with Department of Ex-Servicemen Welfare.
- Pre-Negotiation Committee (PNC) meetings were held in respect of 70 CPSEs to discuss the MoU Parameters & targets for the year 2019-20.
- 8. As per advice of CVC, a draft guideline redefining the Role of Government Directors on the Boards of CPSEs was circulated to all administrative Ministries/Departments for their comments/views.
- 9. The information on CAPEX of select CPSEs for the month of January,
