1. Capital Expenditure in CPSEs and other Government organizations:

The information of CAPEX achievement for select CPSES (having annual CAPEX estimates of ₹100 crore or more) and other Government organizations [viz. Railway Board, National Highway Authority of India, Delhi Metro Rail Corporation and Damodar Valley Corporation] for the year 2024-25 till the end of March, 2025 was compiled. These entities have achieved CAPEX of ₹8.07 lakh crore, which is 102.58%, of the revised estimates of ₹7.87 lakh crore for the financial year 2024-25.

- 2. Governance of CPSEs:
- i. Based on the recommendations of Apex Committee and approval of Hon'ble Minister (Finance), Indian Railway Catering and Tourism Corporation (IRCTC) and Indian Railway Finance Corporation (IRFC) were granted Navratna status on 03rd March, 2025.
- ii. The Department of Public Enterprises (DPE) has sent its consent on the proposal of Ministry of Petroleum and Natural Gas (MoPNG) for Creation of 02 Posts of Executive Director (ED) in Mangalore Refinery and Petrochemicals Limited (MRPL) on 12th March, 2025.
- iii. The Department of Public Enterprises (DPE) has sent its consent on exemption of 04 below Board level posts from rule of immediate absorption in Cement Corporation of India Limited (CCIL) on 25th March, 2025.
- 3. Inter-Ministerial Meetings and CCEA/Cabinet Notes:
- (i) 01 IMC meeting was held during the month of March, 2025 to review the progress of closure of CPSE under D/o Defence Production.
- (ii) 02 IMG meetings were held during the month of March, 2025.
- (iii) DPE participated in 10th round of India-EU FTA negotiations held on 25th and 26th March, 2025 at Brussels.
- (iv) DPE participated in the 44th meeting of Working Party on State Ownership and Privatisation Practices organized by OECD on 19-20 March, 2025 in Paris.
- (v) DPE organized 03 meetings of Search Committee and conveyed the recommendations of Search Committee for filling up 208 positions of Independent (Non-official) Directors on the Boards of various CPSEs.
- (vi) The instructions of Ministry of Micro, Small & Medium Enterprises for adoption of Zero Defect Zero Effect (ZED) and Lean certification schemes

by MSME vendors of Central Public Sector Enterprises (CPSES) were circulated to CPSEs for necessary action.

- 4. Capacity Building:
- (i) 79 employees of DPE (including YPs/ YAs) have completed 2170 courses on I-GOT portal till 31<sup>st</sup> March, 2025.
- (ii) 02 sessions of Rashtriya Karamyogi Jan Seva programme were organized in DPE.
- 5. Status of AMRCD cases:

As per updated status, 196 cases were reported/registered on the portal. 50 cases were rejected at the level of Financial Advisors. 51 cases have been settled and 72 cases are with the Committee of Secretaries for decisions. Remaining 23 cases are pending with Financial Advisors concerned for their scrutiny and approval.
