Monthly Summary of DPE for the month of April, 2025

1. Capital Expenditure in CPSEs and other Government organizations: -

CAPEX target for the year 2025-26 has been workout at Rs. 7.85 lakh crore for the select CPSEs and other government organization having CAPEX target Rs. 100 crore & above.

2. Governance of CPSEs: -

DPE revised DA rates for the CPSEs following 2017, 2007, 1997, 1992 & 1987 IDA pay scales w.e.f. 01.04.2025 and also revised DA rates for the CPSEs following 7th CPC, 6th CPC & 5th CPC CDA pay scales w.e.f. 01.01.2025.

3. Inter-Ministerial Meetings and CCEA/Cabinet Notes: -

- (i) 01 CMCD meeting was attended during the month of April, 2025.
- (ii) DPE organized meeting with 31 Ratna CPSEs on 8th April, 2025 to discuss issues related to their Succession Planning and Leadership Development Plans.
- (iii) DPE conducted a workshop 'on the process of creating VPN accounts for concerned CPSE executives to access CPSE-SPARROW system' during the month of April, 2025 in Mumbai, Kolkata, Bengaluru and in Bhopal.

4. Proposal of closure of CPSEs: -

In pursuance of new PSE Policy dated 04.02.2021, an advance Copy of the draft CCEA note in respect of closure of 7 CPSEs (British India Corporation Ltd. (BIC) & National Textiles Corporation Ltd. (NTC) along with its 5 subsidiaries) under the administrative control of M/o Textiles (MoT) and 2 CPSEs (State Trading Corporation of India Ltd. (STC) & Project and Equipment Corporation Ltd. (PEC)) under the administrative control of D/o Commerce (DoC) were sent to PMO and Cabinet Secretariat on 23.08.2022. Further, information/ clarifications were also furnished as and when asked by PMO. DPE recently furnished information vide its ID dated 09.09.2024 & 04.11.2024 in respect of MoT and DoC respectively, since then, the matter is pending with PMO.

5. Capacity Building: -

85 employees of DPE (including YPs/ YAs) have completed 2864 courses on I-GOT portal till 30th April, 2025.

6. Mission Recruitment: -

3144 new appointees of CPSEs were covered in 15th tranche of Rozgar Mela held on 26th April, 2025.

7. Status of AMRCD cases: -

Based on the report obtained from AMRCD dashboard as on 05.05.2025, 204 cases were reported on the portal. 51 cases were rejected at the level of Financial Advisors. 51 cases have been settled and 73 cases are with the Committee of Secretaries for decisions. Remaining 29 cases are pending with Financial Advisors concerned for their scrutiny and approval.
