

Monthly achievements of DPE for the month of June, 2022

1. CAPEX targets:

The information relating to annual CAPEX targets of Rs. 6.61 lakh crores (Budget Estimates) and its achievement in respect of select CPSEs (having annual CAPEX target of Rs. 100 crores & above) and other government organizations up to the month of June, 2022 was submitted to PMO on 5th July, 2022. Against an estimated expenditure of Rs. 6.62 lakh crores (approx.), achievement is Rs. 1.37 lakh crores (approx.) or about 20.72%.

2. CCEA/ Cabinet Notes:

i) Two draft Cabinet/ CCEA Notes of other Department received for comments were examined in DPE and comments furnished thereon to obtain approval of Hon'ble Finance Minister.

ii) A draft CCEA Note for "In-principle" approval for closure of National Textiles Corporation Ltd. (NTC) and British India Corporation Ltd. (BIC) was circulated for inter-ministerial consultation on 20.06.2022.

iii) National Land Monetisation Corporation (NLMC) was incorporated on 03.06.2022 with an interim board.

3. MoU Dashboard:

Two outreach programs on MoU Dashboard guidelines were organized during the month. One program was organized in Gandhi Nagar on 10.06.2022 in respect of Oil Exploration, Oil Marketing, Gas Transmission, Fertilizers, Manufacturing, Consultancy & Construction, Mining, Steel, Coal, Trading & Services Sectors. Another Outreach program on MoU Dashboard for FY 2022-23 & onwards was organized at Delhi on 28.06.2022 in respect of Multiproduct, Consultancy & Construction, Manufacturing, Trading & Services Sectors.

4. Governance of CPSEs:

i) DPE agreed to exempt the post of General Manager (works), E-7 level in ITPO from the rule of immediate absorption for a period of three years' w.e.f. date of joining.

ii) DPE issued the instructions for facilitating purchase/use of electric vehicles by CPSEs.

iii) Pre-event activities were undertaken for the first ever "INDUCTION AND CAPACITY BUILDING WORKSHOP" OF INDEPENDENT DIRECTORS (ID) from 11th – 17th July, 2022 in New Delhi for about 400 Independent Directors of CPSEs in partnership with IICA and CBC. The preparatory work also included registration of the IDs on the OTNS system of DPE and on boarding the IDs on the UDYAM BHARAT application for pre-induction training need assessment survey. Further, pre-induction activities were organised for the IDs at their respective CPSEs.

5. Inter-Ministerial Meetings and Special Campaign:

i) Four IMG/CGD/ECoS meetings were held during the month.

ii) The meeting of Inter-Ministerial Committee was held on 1st June, 2022 to consider the proposal of Ministry of Power for grant of Maharatna status to REC limited. The IMC meeting was held on 1st June, 2022 under the Chairmanship of Secretary, DPE and recommended the grant of Maharatna status to REC for consideration of the Apex Committee.

iii)DPE participated in the negotiations relating to India-UK FTA, India-EU FTA and India-Canada CEPA.

6. Events organized during the Azadi Ka Amrit Mahotsav-

DPE organized a series of events under the aegis of Azadi Ka Amrit Mahotsav during the iconic week of 6th to 12th June, 2022 at Mahatma Mandir, Gandhi Nagar. These included: -

a) An Exhibition on ‘Nation Building and CPSEs’ from 9th June, 2022 to 12th June, 2022– The exhibition was inaugurated by Hon’ble Finance Minister 9th June, 2022. Hon’ble Chief Minister of Gujarat joined the inaugural function of the exhibition. The exhibition was open to public from 10th to 12th June, 2022. 75 CPSEs set up stalls showcasing their products and services which have contributed to the development of the country. A number of cultural programmes and quiz shows on Indian economy were also organized on the side-lines of the exhibition.

b) Roundtable of CEOs of CPSEs ‘Role of CPSEs for a self-reliant India’ was held on 9th June wherein CMDs/Directors of CPSEs deliberated on framing of an appropriate plan of action for their respective CPSEs and sector.

c) **Plantation drive across CPSEs** - Participating CPSEs undertook plantation drives across country on their designated days to plant 75,000 saplings in their offices, townships, production units, etc.

d) **Workshop on the Corporate Social Responsibility (CSR) with special focus on Aspirational Districts–** This daylong workshop was held on 10th June and brought together CSR stakeholders, i.e., Central Public Enterprises, Representatives from Aspirational Districts, NITI Aayog and Civil Society Organizations on one platform for experience sharing and developing appropriate models of interventions which would be sustainable and complement existing Government interventions in area of health/nutrition, etc. Hon’ble Minister of State (Finance) inaugurated the workshop virtually which was attended by more than 200 participants (95 from various civil society organizations and 112 from CPSEs).

e) **Workshops on Procurement by CPSEs with special focus on vendor interface with Micro & Small Enterprises (MSEs) and vendor interface with GeM –** The workshop aimed at encouraging and promoting public procurement by MSEs (vendors or potential vendors) and through G.E.M. by CPSEs. The workshop offered insights on Government initiatives to support MSEs, existing best practices, opportunity for networking, discussions between CPSEs and MSEs to discuss business opportunities and resolve any issues or concerns. During the workshop, an overview of GeM was also presented along with its new initiatives, sharing of success stories on GeM. Buyers & Sellers perspectives were also presented in the workshop through a panel discussion. These workshops were attended by more than 300 participants (169 from MSEs and 146 from CPSEs).

f) **Conversion of townships of CPSEs into Mini Smart Cities** - Smart Cities is one of the important initiatives taken by the Government of India. 15 CPSEs are developing some of their townships as Mini Smart Cities as per parameters identified by Ministry of Housing & Urban Affairs. The activities relating to conversion of these townships into Mini Smart Cities were inaugurated during the week. Hon’ble Finance Minister and Hon’ble Chief Minister of Gujarat inaugurated 2 Mini Smart Cities of CPSEs, i.e., NTPC-Solapur and BEL-Bengaluru on 9th June, 2022.

g) Workshop on Memorandum of Understanding (MoU) system for performance evaluation of CPSEs– The daylong workshop organized on 10th June, had discussions between CPSEs and DPE to smoothen implementation of MoU system. The workshop was attended by around 80 senior executives of various CPSEs.
