**Monthly Summary for the Cabinet for the month of January, 2022**

An update on the principal activities and key initiatives under taken by the Department of Public Enterprises (DPE) during the month of **January, 2022** is indicated below:-

**1. CAPEX targets:**

The information relating to annual CAPEX targets of Rs.5.95 lakh crores and its achievement in respect of select CPSEs & other government organisations up to the month of January, 2022 was submitted to PMO on 4<sup>th</sup> February, 2022. Against an estimated annual expenditure of Rs.5.95 lakh crores (approx.), achievement is Rs. 4.31 lakh crores (approx.) or about 72.56%.

**2. MoU Framework:**

Final MoUs for FY 2021-22 for 40 CPSEs were issued during the month. A total of 107 MoUs have been issued up to 31.01.2022.

**3. Pay Revision and Wage Notification:**

DA rates due from 01.01.2022 for Board level and below Board level executives including Non-unionized supervisors in CPSEs in IDA pattern pay scales (2017/2007/1997/1992/1987) were issued vide OMs dated 24.01.2022 & 28.01.2022 respectively.

**4. Corporate governance of CPSEs:**

DPE approved exemption of 405 below Board level posts in Rail Vikas Nigam Limited from the rule of immediate absorption for a period of 3 years beyond date 10<sup>th</sup> January, 2022.

**5. Instructions of various Ministries to all CPSEs:**

- i. The instructions of Ministry of Electronics & Information regarding Security Audit of IT Infrastructure, Applications and Websites were circulated to all CPSEs for information and compliance.
- ii. The instructions of Department of Expenditure (DoE) for extending the validity of DoE's earlier OM dated 12.11.2020 regarding reduction in Performance Security were forwarded to all CPSEs for information and compliance.

**6. New Public Sector Enterprises (PSE) Policy:**

A meeting of Committee of Group of Officers (CGO) constituted to identify the CPSEs for closure or privatization in the non-strategic sectors as outlined in the New Public Sector Enterprises (PSE) Policy was held on 27.01.2022 under the chairmanship of Chief Executive Officer, NITI Aayog to consider the CPSEs under the administrative control of Ministry of Textiles.

**7. Training programmes/workshops:**

- i. DPE organized three training programmes and one workshop through online mode on issues related to functioning of CPSEs in which were attended by 219 employees of various CPSEs/ SLPEs.
- ii. DPE in association with the Institute of Chartered Accountants of India (ICAI) organised a one day orientation programme for newly appointed Non-official Directors of CPSEs for capacity building of Directors of Central Public Sector Enterprises (CPSEs) on 28<sup>th</sup> January, 2022, through online mode. The programme was attended by 130 Non-Official (Independent) Directors of various CPSEs.
