

**Monthly achievements of DPE for the month of October, 2017**

1. 26 meetings of Inter-Ministerial Committee (IMC) were held to evaluate the MoU for the year 2016-17 and finalize score/rating for recommendation to the Chairman, High Power Committee (HPC) for approval.
2. A meeting was held on 24<sup>th</sup> October, 2017 on Investment of Surplus Fund under the chairmanship of Secretary, DPE to examine the possibility of replicating Gujarat Model in CPSEs.
3. A Training Programme was organized on "Finance for non-finance Executives" in association with National Productivity Council during 9<sup>th</sup> to 13<sup>th</sup> October, 2017 in Gangtok.
4. The Department has submitted information on CAPEX of select CPSEs to PMO on 10<sup>th</sup> October, 2017.
5. The following arbitration awards have been made by PMA during the month of October, 2017:-
  - i. Settlement of dispute between M/s Tamil Nadu Civil Supplies Corporation (TNSC) and M/s Gail (India) Limited relating to Gas Sales and Transmission Agreement dated 23.12.2010 for the period 01.01.2011 to 31.12.2015.
  - ii. Settlement of dispute between M/s Rites Limited and M/s Vishakhapatnam Port Trust relating to works for VPT/R&D Yard (i) additional line No.1E on Eastern side at R&D yard (ii) 1 Central Panel Cabin replacing existing 4 lines at R&D Yard vide Work Order No. 96 IENG/EE (RLYS) of 2010 dated 23.09.2010.
  - iii. Settlement of dispute between M/s Engineering Projects India Ltd. (EPIL) and M/s Chennai Port Trust (CPT) relating to the project "Extension of Eastern Break Water by 125 M along the original alignment in fishing harbour for Chennai Port Trust", vide LOA JDR/8981/05/E dated 29.02.2008.
6. DPE organized a workshop regarding capacity building for below Board Level employees of the CPSEs in establishment and general management issues under the RDC Scheme through ISTM on 23<sup>rd</sup>- 27<sup>th</sup> October, 2017.
7. Revised guidelines were put-up for the decision in a meeting of CoS held on 20.10.2017 on the subject of time bound closure of sick/loss making CPSEs and disposal of assets.
8. 7 IMG meetings were attended during the month of October, 2017.
9. DA orders (due w.e.f. 01.10.2017) for 1997 & 2007 and 1987, 1992 & 2017 IDA Pattern of pay scales were issued vide OMs dated 05.10.2017 and 06.10.2017 respectively. Further, DA orders (due w.e.f. 01.07.2017) for employees of CPSE following 5<sup>th</sup>, 6<sup>th</sup> and 7<sup>th</sup> CPC CDA Pattern of pay scales were issued vide OMs dated 03.10.2017 and 05.10.2017 respectively.
10. A Cabinet Note regarding 8<sup>th</sup> Round Wage Policy for Wage Negotiation in respect of workmen of CPSEs w.e.f. 01.01.2017 was forwarded to the Cabinet Secretariat.
