

Monthly achievements of DPE for the month of July, 2020

An update on the principal activities and key initiatives under taken by the Department of Public Enterprises (DPE) during the month of July, 2020 is indicated below:-

1. Presentations on status of CAPEX achievements of select CPSEs under M/o Petroleum & Natural Gas, Power, Coal, Atomic Energy, Steel and Railway were made before the Hon'ble Finance Minister by Secretary (PE) on 07.07.2020 & 23.07.2020.
2. MoU Score/ Rating of 30 CPSEs which had remained pending for the year 2018-19 was got approved from the High Power Committee (HPC) on 9th July, 2020 and uploaded on MoU website.
3. On the direction of High Powered Committee (HPC), a meeting on detailed review of MoU parameters, guidelines and the institutional mechanism for administering them was conducted on 24.07.2020 with Chief Economic Advisor, Member PESB, Secretary Expenditure, Secretary Economic Affairs, Member Secretary, Tariff Commission and representatives from NITI Aayog, DIPAM, Department of Revenue and M/o Statistics & Programme Implementation.
4. Pre-Negotiation Committee (PNC) meetings were conducted in respect of 138 CPSEs (70 CPSEs up-to previous month) to discuss the MoU parameters & targets for the year 2020-21.
5. The information for CAPEX of select CPSEs and other organizations for the month of June, 2020 has been submitted to PMO on 8th July, 2020.
6. A Draft Cabinet Note (DCN) was circulated on 17th July, 2020 on revised guidelines of DPE on "time bound closure of sick/loss making CPSEs and disposal of movable and immovable assets" for inter-ministerial consultation inviting comments of the concerned Ministries/ Departments/ Organizations prepared on the basis of the recommendations of CoS on 22nd May, 2020.
7. A meeting was held on 21st July, 2020 between the officers of DPE and GeM to review the status of procurement by CPSEs through GeM. In the meeting, inter-alia, various issues relating to status of completion of all the requests made by CPSEs to GeM for creation/ modification of new/ existing products/ services, ATC, etc. on GeM portal were discussed.
8. For the first time Annual Performance Appraisal Reports (APAR) for the year 2018-2019 for Board level incumbents of CPSEs has been completed in the new online SPARROW-CPSE system.
9. The simplified procedure for verification of character and antecedents of Ex-Servicemen and Ex-Central Government employees selected for appointment to the civil posts of the GoI issued by DoPT has been extended mutatis-mutandis to all CPSEs vide DPE OM NO. DPE-GM 09/0001/2020-FTS-11458 dated 21.07.2020.
10. Four Cabinet/ CCEA/ GoM Notes of other Ministries/ Departments received for comments have been examined and issued comments thereon.
11. Seven IMG/ CGD meetings were attended during the month of July, 2020.
