Subject: Prescription of qualification/experience for various Board level positions in PSUs.

A reference is invited to the Ministry of Personnel, PG & Pensions, Department of Personnel & Training O.M. No.44011/8/2006-Estt.(B) dated 22nd April, 2008 on the subject mentioned above.

- 2. The issue of prescription of qualification/experience for various Board level positions in PSUs and laying down norms to infuse more transparency and objectivity in the PESB selections has further been considered by the Government and it has been decided that the Administrative Ministry concerned may, in consultation with the PESB, finalise the eligibility criteria in respect of various Board level positions in different PSUs under their control. Once the recruitment norms are finalized, such norms should have validity for a minimum period of 5 years. The finalised eligibility criteria should be open for the information of the general public.
- 3. In case of any disagreement or dispute between the PESB and the Administrative Ministry in relation to finalization of eligibility conditions, the matter should be referred to ACC for final orders.
- 4. All administrative Ministries/Departments are requested to take note of the above decision for necessary action.

2. लोक उद्यम चयन बोर्ड के कार्य क्षेत्र का विस्तार करने की दृष्टि से अब यह निर्णय लिया गया है कि दिनांक 3 मार्च, 1987 के संकल्प में, संकल्प के पैरा 7.2 में निम्नलिखित को जोड़ते हुए संशोधन किया जाएगा:—

No. 44011/8/2006-Estt.(B).—In order to evolve a sound managerial personnel policy for the Public Sector Enterprises and, in particular, to advise the Government on appointments to the top management posts, the Government of India constituted a Public Enterprises Selection Board (PESB) by a Resolution dated 30th August, 1974. The policy relating to the functions, membership, methodology for selection and infrastructure of the Board, was revised by the Government of India. Ministry of Personnel, Public Grievances and Pensions (Department or Personnel and Training) Resolution No. 27(21)EO/ 86(ACC) dated 3rd March, 1987. Modifications in the Resolution of 3rd March, 1987 were made by Amendments No. 6(9)EO/89(ACC) dated 6th September, 1989, No. 27(8)EO/93(ACC) dated 2nd September, 1993 and No. 27(18)EO/99(ACC) dated 19th April, 2000.

2. With a view to enlarging the scope of the PESB, it has now been decided that the Resolution dated 3rd March, 1987 shall be amended by adding the following in paragraph 7.2 of the Resolution:—

"Candidates from State Public Sector Enterprises and the private sector subject to fulfilling the eligibility criteria, will also be considered as non internal candidates alongwith the candidates of other public sector enterprises, for a period of five years from the date of this Resolution".
