Subject: Annual contract for supply of Toner, Cartridges in the Department of Public Enterprises for the year 2015-2016 - reg.

Department of Public Enterprises (DPE) invites sealed quotations for Supply of Toners and Cartridges on annual contract basis. The details of the items are as given in Annexure. The tenders in sealed covers should be submitted to the undersigned on or before 3.00 p.m. on 21.08.2015 along with earnest money deposit of Rs.30,000/- (Thirty thousand only) in the form of a Demand Draft/FDR in favour of DDO Department of Public Enterprises. The quotations will be opened on the same day at 3.30 p.m. in Department of Public Enterprises, Room No. 408, Block No.14, CGO Complex, Lodi Road, in the presence of the tenderers who wish to be present. The terms and conditions of the contract are as under:-

- The contract will be for a period of one year from the date of its award but can be terminated at any time without assigning any reason. Taxes, if any may be quoted separately, failing which no amount towards any tax will be paid. Rates quoted shall be valid for entire period of the contract and no revision of rate will be allowed.
- 2. In no case Department shall pay the higher rate than printed rates irrespective of quoted/agreed rates.
- 3. Only those firms may send their quotations who are Registered/ Authorized Suppliers/Resellers (RSRs)/dealers of toners and cartridges mentioned in Annexure. A certificate to this effect must be enclosed with the quotations without which the quotations will not be considered.
- 4. Tenderer should enclose PAN/VAT/TIN.
- 5. The firm submitting quotations should be well equipped and should have the required infrastructure and expertise to undertake the job of supply of toner and cartridges. The firm should have achieved a minimum turnover of Rs.30.00 lakh (Rs Thirty lakh only) through sale of toner and cartridges during the last three financial years i.e., 2012-13, 2013-14, 2014-15.

- 6. The Contractor will be required to contact the General Administration Section of this Department to take orders for supply of toner and cartridges items.
- 7. Since the items under the contract are very often required on urgent supply basis, the contractor must be based in Delhi/Delhi NCR with the capability to ensure timely supplies. Delay in supply will be considered as non-performance of the contract resulting into termination of the contract and forfeiture of the security.
- 8. The firm will supply Toner/Cartridges only on written orders from the Department from time to time.
- 9. The successful contractor will have to deposit Rs. 30,000/- (Rs. Thirty Thousand only) in advance as security deposit in the form of DD/FDR in favour of DDO, Department of Public Enterprises to be retained during the contract period.
- 10. In case of violation of the above terms of the contract, the security deposit would be forfeited.
- 11. The earnest Money deposit of Rs. 30,000/- (Thirty Thousand only) mentioned above will be returned after the contract has been finalized and contractor selected.
- 12. The firm should have the experience of supplying toner/cartridge in Government Departments.
- 13. The firm should enclose a certificate that it has not been black-listed by any Ministry/Government Department.
- 14. The contract for supply of tonner/ cartridges may be extended for another one year on the same rates and same terms & conditions.
- 15. If the Department of Public Enterprises desires to purchase any other Toner/ Cartridge other than mentioned in the Annexure, the Contractor will also have to supply the same.

2. Accordingly, interest parties may send their quotation in sealed covers to the undersigned on or before 3.00 PM on 21.08.2015 along with earnest money deposit of Rs.30,000/- (Rs. Thirty thousand only) in the form of DD/FDR in favour of DDO, Department of Public Enterprises.
