1. Confirmation of minutes of the 76<sup>th</sup> Meeting of BRPSE held on 22.12.2009

The minutes of the  $76^{th}$  meeting held on 22.12.2009 have been circulated vide OM No. BRPSE /2 (76)/2009 dated 11.1.2010

2. Consideration of proposal of turnaround package of North Eastern Handicrafts and Handlooms Development Corporation Ltd. (NEHHDC). (Time: 3.00PM to 3.30 PM)

A copy each of the documents (i) Proposal on NEHHDC, (ii) Report of Corporate plan on NEHHDC prepared by Administrative Staff College of India, (iii) Annual Report of NEHHDC for the year 2008-09, and (iv) additional information on the proposal furnished vide OM dated 3.12.2009 submitted by M/o North Eastern Development Region on the proposal of restructuring NEHHDC were already circulated vide OM No.BRPSE/2(77)/2010 dated 12.1.2010.

3. Consideration of the present status of the implementation of the recommendations of BRPSE on the revival of Indian Drugs & Pharmaceuticals Ltd. (IDPL) & its subsidiaries viz. IDPL (Tamil Nadu) Ltd. and Bihar Drugs & Organic Chemicals Ltd. (*Time: 3.30PM to 4.00 PM*)

The Board considered the revival proposal of Indian Drugs & Pharmaceuticals Ltd. (IDPL) & its subsidiaries viz. IDPL (Tamil Nadu) Ltd. and Bihar Drugs & Organic Chemicals Ltd. in its 46<sup>th</sup> meeting held on 9.3.2007 and recommended, inter alia, a revival package for IDPL envisaging cash assistance of Rs.361 crores in the form of interest bearing bridge loan and non-cash assistance of Rs.2861.76 crores in the form of waiver of loan/interest/guarantee fee and also merger of Muzaffarpur & Chennai units back into IDPL.

- 4. Consideration of the implementation of the revival package sanctioned to the following companies and their post revival performance. HAL & HOCL will make a presentation; inter alia, about the present status of implementation of the approval of Government and on post revival performance along with the future outlook/performance of the company:
  - (a) **Hindustan Antibiotics Ltd.** (**HAL**) (*Time: 4.00PM to 4.30 PM*): The Board considered the revival proposal of HAL submitted by D/o Pharmaceuticals in its 18<sup>th</sup> meeting held on 22.7.2005 and recommended, inter alia, a rehabilitation scheme involving cash infusion of Rs. 136.62 crores, which is to be financed by the sale of land to the extent of Rs.56 crores and infusion of funds by Govt. of India as equity/interest free loan/grant to the extent of Rs.80.62 crores and non-cash assistance of Rs.123.75 crores in the form of waivers, etc. Based on the recommendations of the BRPSE, Government had approved a revival package on 9.3.2006 envisaging cash infusion of Rs.137.59 crores and non-cash assistance of Rs.267.57 crores for revival of HAL.
  - (b) Hindustan Organic Chemicals Ltd. (HOCL) (*Time: 4.30PM to 5.00 PM*): The Board considered the revival proposal of Hindustan Organic Chemicals Ltd. (HOCL) submitted by D/o Chemicals & Petrochemicals in its 24<sup>th</sup> meeting held on 18.10.2005 and recommended, inter alia, a revival package envisaging cash infusion of Rs.250 crores and non-cash assistance of Rs.100 crores. Based on the recommendations of the BRPSE, Government had approved a revival package on 9.3.2006 envisaging cash infusion of Rs.250 crores in the form of 8% Redeemable non-cumulative preference shares for repayment of high cost overdue Bonds and waiver of penal interest on interest upto 31.3.2005 and Continuation of GOI guarantee of Rs. 100 crores for full term of ten years (issue date 19.12.2001) to be utilized to liquidate high cost debt.
