1. Confirmation of minutes of the 77th Meeting of BRPSE held on 4.2.2010

The minutes of the 77^{th} meeting held on 4.2.2010 have been circulated vide OM No. BRPSE /2 (77)/2010 dated 18.2.2010

2. Consideration of the present status of the implementation of the recommendations of BRPSE on the revival of Hindustan Steelworks Construction Ltd. (HSWL) (*Time: 3.00PM to 3.20 PM*)

The Board considered the revival proposal of Hindustan Steelworks Construction Ltd in its 58th meeting held on 13.5.2008 and recommended, inter alia, a revival package for HSWL envisaging cash assistance of Rs.589.76 crores and non-cash assistance of Rs.970.60 crores for revival of HSWL.

3. Consideration of the business plan of Hindustan Photo Films manufacturing Company Ltd. (HPFL) on the proposal on the future of HPFL. (Time: 3.20PM to 3.50 PM)

The present status of the recommendations of the Board on the proposal on the future of HPFL was last considered by BRPSE in its 76th meeting held on 22.12.2009 and advised DHI/HPFL to submit a comprehensive revival plan with its business plan with in two months for its consideration after taking into account the issues such as (i) sanction of Rs.30 crores for working capital to HPFL, and (ii) incorporating the concession and reliefs package extended by Government of Tamilnadu on various concessions and reliefs asked by HPFL. It was further mentioned that the Board would also like to have the representative of Government of Tamilnadu in the meeting while considering the proposal of the company."

4. Consideration of the implementation of the revival package sanctioned by the Government to Andrew Yule & Co. Ltd.(AYCL) and its post revival performance. AYCL will make a presentation; inter alia, about the present status of implementation of the approval of Government and on post revival performance along with the future outlook/performance of the company: (Time: 3.50PM to 4.20 PM)

The Board considered the revival proposal of AYCL submitted by D/o Heavy Industries in its 36th meeting held on 9.5.2006 and recommended, inter alia, a rehabilitation scheme of Rs.655.49 crores involving cash infusion of Rs. 146.62 crores. Based on the recommendations of the BRPSE, Government had approved a revival package of Rs.457.14 on 22.2.2007 for revival of AYCL with the direction that the issue of infusion of funds by GOI or by Joint Venture or a Strategic Partner will be sorted out by M/o of Finance and the M/o Heavy Industries.
