The undersigned is directed to refer to this Department's O.M. of even no. dated 17th June, 2020 (copy enclosed) and Department of Personnel & Training O.M. No. 16017/12/2020-iGOT dated 1st April, 2021 on the subject mentioned above and to state that no foreign training shall be conducted by CPSEs till further orders.

2. In case a CPSE proposes to conduct any foreign training under exceptional circumstances, prior approval of DPE may be obtained through the concerned administrative Ministry and DPE will consult Department of Personnel & Training before taking a decision on such proposal.

3. All administrative Ministries/Departments are requested to bring the above instructions to the notice of all CPSEs under their respective jurisdiction for information and compliance.


OFFICE MEMORANDUM
