Monthly achievements in respect of DPE for the month of August, 2022

1. CAPEX targets:

The information relating to annual CAPEX targets of Rs. 6.62 lakh crores (Budget Estimates) and its achievement in respect of select CPSEs (having annual CAPEX target of Rs. 100 crores & above) and other government organizations up to the month of August, 2022 was submitted to PMO on 5th September, 2022. Against an estimated expenditure of Rs. 6.62 lakh crores (approx.), the achievement is Rs. 2.27 lakh crores (approx.) i.e. about 34.36% as on 31.08.2022.

2. Governance of CPSEs:

i) The meeting of Parliamentary Committee on Welfare of SCs and STs was held on 02.08.2022 with special reference to Maharatna CPSEs.

ii) Seven below board level posts in Security Printing and Minting Corporation Limited (SPMCIL) were exempted from the rule of immediate absorption for a period of 3 years beyond 11.08.2022.

iii) The proposal of Ministry of Petroleum & Natural Gas regarding redesignation of the post of Chairman Indian Oil Corporation limited (IOCL) as Chairman and Managing Director (CMD) IOCL has been considered in consultation with Public Enterprises Selection Board (PESB) and agreed to.

iv) The meeting of Apex Committee under the Chairmanship of Cabinet Secretary was held on 29.08.2022 to consider the proposal for grant of Maharatna status to REC limited.

v) DPE issued MoU for the year 2022-23 in respect of 4 CPSEs during the month of August, 2022.

3. Inter-Ministerial Meetings and Cabinet Notes/ CCEA Notes:

i) Three IMG, 2 CMCDC meetings held during the month.

ii) DPE furnished its comments on the following notes circulated for inter-ministerial consultations:

a) Note for Cabinet Committee on Economic Affairs circulated by the Ministry of Skill Development & Entrepreneurship for continuation of three Central Sector Schemes as sub-components of 'Skill India Programme' from FY 2022-23 to 2025-26.

b) PIB/EFC Memo for appraisal of International Exhibition-cum-Convention Centre Project circulated by the Department of Commerce.

c) Draft Note for the Cabinet on 'Draft Tourism Policy' circulated by the Ministry of Tourism.

4. Events and Activities implemented:

i) DPE participated in the Har Ghar Tiranga campaign successfully.

ii) All CPSEs were requested for impactful participation in the 'Har Ghar Tiranga' campaign as per directions of Committee of Secretaries.

iii) As requested by the Department of Expenditure, the updated manuals on a) Procurement of Goods, b) Procurement of works, and c) Procurement of Consultancy & other services were circulated to all CPSEs for compliance.

5. New Public Sector Enterprises (PSE) Policy:

Three CGO (Committee of Group of Officers) meetings were held and considered the CPSEs under D/o Pharma, D/o Telecommunications, M/o Housing and Urban Affairs, M/o Health and Family and D/o Fertilizers for closure/ disinvestment.

6. Public Enterprises Survey:

i) The integrated Public Enterprises Survey portal was made online in August, 2022 and PE Survey 2021-22 has also been made go live.

ii) A module for collecting information relating to CSR expenditure by CPSEs has been set up as part of PE survey portal and all CPSEs have been requested to update the data on monthly basis.
