**Monthly achievement of the Department of Public Enterprises for the month of May, 2022**

1. The information relating to annual CAPEX targets of Rs. 6.61 lakh crores (budget estimates) and its achievement in respect of select CPSEs (having annual CAPEX target of Rs. 100 crores & above) and other government organizations up to the month of May, 2022 was submitted to PMO on 6<sup>th</sup> June, 2022. Against an estimated expenditure of Rs. 6.62 lakh crores (approx.), achievement is Rs. 0.72 lakh crores (approx.) or about 10.84%.

**2. MoU Dashboard:**

An Outreach program on MoU Dashboard for FY 2021-22 & onwards was conducted in Kasauli on 09.05.2022 in respect of Power Generation, Power Transmission & Finance sectors.

**3. Matters relating to procurement through GeM and MSMEs:**

DPE circulated the guideline issued by the Department of Expenditure regarding amendment to Manual for Procurement of Goods, 2017 and Manual of Procurement of Works, 2019 in respect of withdrawal of offer by L-1.

**4. Corporate governance of CPSEs:**

- i. The proposal of M/o Information and Broadcasting for exempting the one post of General Manager in National Film Development Corporation (NFDC) regional office at Delhi and one post of Manager in NFDC head office Mumbai from the rule of immediate absorption w.e.f. date of joining was processed and agreed to.
- ii. DPE agreed to proposal of Airports Authority of India Limited for creation of 340 below board level Posts of Air Traffic Controllers (ATCOs) w.e.f. 12/05/2022.
- iii. The proposal of Initial Categorization of Mission Karamyogi as Schedule “A” CPSE was considered in consultation with Public Enterprises Selection Board and was submitted to Cabinet Secretariat.
- iv. DPE considered the proposal of Ministry of Petroleum and Natural Gas for redesignation of Chairman IOCL as Chairman and Managing Director (CMD) IOCL in consultation with PESB and agreed to.
- v. DPE considered and agreed to the proposal of Ministry of Power for redesignation of post of Director (Commercial) as Director (Fuel) in NTPC.
- vi. A meeting of Search Committee was held on 31/05/2022 to consider the proposal for appointment of Non-Official Directors on the board of various CPSEs. The Search Committee recommended 13 names for appointment as NoD.
- vii. The National Land Monetization Corporation Limited (NLML) is incorporated on 03.06.2022.
- viii. A detailed presentation was made to the Cabinet Secretary by DPE on 18<sup>th</sup> May, 2022 regarding ‘Delegation of Autonomy to and Restructuring the Boards of Ratna and other CPSEs’.

**5. Inter-Ministerial Meetings and Special Campaign:**

i) DPE furnished its comments on the following notes circulated for inter-ministerial consultations:

- a. Draft Cabinet Note to amend the Public Procurement Policy for Micro & Small Enterprises (MSEs) order, 2012.
- b. Draft Vision @ 2047 report for skill development and Entrepreneurship.

ii) A draft CCEA Note for “In-principle” approval for closure of State Trading Corporation of India Ltd. (STC) and PEC Ltd. (PEC) under D/o Commerce was circulated for inter-ministerial consultation on 09.05.2022.

Meeting of Oversight Committee was held on 30<sup>th</sup> May, 2022 to finalize training programmes/workshops to be conducted under RDC scheme for the year 2022-23.
