## Monthly Achievements – December, 2016

1. The Third Pay Revision Committee constituted by Government vide resolution dated 09.06.2016 for reviewing the structure of pay scales, allowances, perquisites and other benefits for Board level, Below Board level Executives and non-unionized supervisory staff has submitted its recommendations and these are under examination.
2. The CAPEX targets of select CPSE's were reviewed by PMO during this period. As a follow up of the meeting, a note has been submitted to PMO on the Cash & Bank balances lying with CPSEs.
3. The Inter-Ministerial Committee (IMC) for evaluation of MoU's conducted 195 meetings (161 meetings during this month) and has completed the evaluation for the year 2015-16 in respect of 193 CPSEs. Two CPSEs were evaluated for the year 2014-15. The recommendations of the IMC have been forwarded to the High Powered Committee for approval.
4. The MoU Guidelines for the year 2017-18 onwards were issued on 16<sup>th</sup> December, 2016 after approval of Chairman, High Powered Committee on MoU.
5. The meeting of the Search Committee was held on 8.12.2016 to consider the proposals for appointment of Non-official Directors on the Boards of CPSEs under various administrative Ministries/ Departments as per following details:-

In pursuance of D.O. letter No.216/2/1/2016-CA.IV dated 5<sup>th</sup> December, 2016 of Cabinet Secretary regarding promotion of digital payments in government and personal transactions, all the CPSEs had been asked vide letters dated 9.12.2016 and 20.12.2016 for preparation of Action Plans to provide training and motivation of employees, their families, consumers, merchants and other similar target groups in digital transactions. Based on the Reports received from 46 CPSEs, about 3.20 lakh employees are being covered for training, of which approx. 2.00 lakhs were covered by 31<sup>st</sup> December, 2016.
7. One PMA Award between Engineering Projects India Limited and Oil Industry Development Board was arbitrated during this period and Rs. 40,000/- was received from the parties as final cost of arbitration proceedings.
