- 1. DPE organized a one-day Workshop on Corporate Social Responsibility (CSR) of Central Public Sector Enterprises (CPSEs) on 11<sup>th</sup> July, 2016 at SCOPE Convention Centre, New Delhi in association with BHEL for senior executives of CPSEs handling implementation of CSR in their respective organisations. The workshop had an overwhelming response and approximately 100 persons participated, including executives from 37 CPSEs and officers of DPE and Ministry of Corporate Affairs.
- 2. Under Plan Scheme RDC, a training programme on Project Management for Executives of CPSEs and SLPEs was organized at IIT, Guwahati during 25<sup>th</sup> to 29<sup>th</sup> July, 2016.
- 3. Under the MoU system of performance evaluation of CPSEs, an alternative system of Task Force was approved by Competent Authority on 12<sup>th</sup> May, 2016. Since then, 431 meetings have taken place (upto previous month 204 meetings had taken place). Out of this, 217 meetings of Standing Committee and 214 meetings of Inter-Ministerial Committee have taken place. In these meetings, targets were approved for 137 CPSEs and 77 CPSEs were exempted from signing of MoU.
- 4. DPE has been periodically furnishing the information for CAPEX of select CPSEs to PMO. The updated information in this regard has been furnished to PMO on 6<sup>th</sup> July, 2016.
- 5. Swachhta Pakhwada was observed by CPSEs during June 16-30, 2016 as per prescribed calendar for various Ministries/Departments. In response to the advisory issued to all the CPSEs by this Department, detailed reports from 65 CPSEs regarding various activities undertaken at about 150 locations were received and forwarded to Ministry of Drinking Water and Sanitation. A Joint Press Conference on this subject with concerned Secretaries and Ministry of Drinking Water and Sanitation was attended by Secretary, PE on 6<sup>th</sup> July, 2016.
- 6. The Citizen Charter of Department of Public Enterprises has been updated and uploaded on the website of the Department (www.dpe.nic.in).
- 7. The Guidelines of Plan Scheme Counselling, Retraining and Redeployment(CRR) for separated employees of CPSEs being implemented by this Department have been revised in July, 2016 to broaden the network of training providers and to

- follow standardized methodology of training, design and delivery through involvement of National Skill Development Corporation (NSDC) empanelled Training partners.
- 8. A Directive Benefit Transfer (DBT) Cell has been constituted on 18<sup>th</sup> July, 2016 in the Department in respect of disbursement under Plan Scheme.
- 9. During the month of July, 2016, DPE examined 5 CCEA/ Cabinet Notes and 14 Inter Ministerial Group (IMG) Meetings were attended.
- 10. DA orders (due 01.07.2016) for 1987, 1992, 1997 & 2007 IDA Pattern of pay scales of CPSEs have been issued vide OMs dated 04.07.2016.
- 11. In accordance with Cabinet Secretary's DO. No. 28(43)EO/2013(ACC)Pt. dated 24<sup>th</sup> June, 2016 regarding updating the status of vacancies in ACC Vacancy Monitoring System (AVMS) and posting details on SUPREMO (AVMS portal), a certificate on updation of AVMS for the month of July, 2016 has been sent to DoPT (ACC Branch).
