**Monthly Summary for the Cabinet for the month of September, 2022**

An update on the principal activities and key initiatives under taken by the Department of Public Enterprises (DPE) during the month of **September, 2022** is indicated below: -

**1. CAPEX targets:**

The information relating to annual CAPEX targets of Rs. 6.62 lakh crores (Budget Estimates) and its achievement in respect of select CPSEs (having annual CAPEX target of Rs. 100 crores & above) and other government organizations up to the month of September, 2022 was submitted to PMO on 6<sup>th</sup> October, 2022. Against an estimated expenditure of Rs. 6.62 lakh crores (approx.), achievement is Rs. 2.85 lakh crores (approx.) i.e. about 43.3% as on 30.09.2022.

**2. Closure of CPSEs:**

A meeting of IMC was held on 29.09.2022 to review the progress of closure of CPSEs under Department of Pharmaceuticals.

**3. Governance of CPSEs:**

- i. Based on the recommendation of Apex Committee and approval of Hon'ble Minister (Finance), REC Ltd. was granted Maharatna status in September, 2022.
- ii. A meeting of Search Committee was held on 15/09/2022 to consider the proposal for appointment of Non-Official Directors on the board of various CPSEs. The Search Committee recommended 24 names for appointment as NoD.
- iii. In order to facilitate implementation of '*Mission Recruitment*' in CPSEs, DPE has constituted a dedicated Cell and directed concerned CPSEs to nominate their Nodal officer and upload relevant details on designated portal of Department of Personnel & Training. Meetings were held with Nodal officers of CPSEs on 19<sup>th</sup> September, 2022 and 30<sup>th</sup> September, 2022 to review the status and to impress upon in this regard.

**4. Inter-Ministerial Meetings and CCEA/ Cabinet Notes:**

- i. One draft Cabinet Note of the D/o Pharmaceuticals on "transfer of Rajasthan Drugs & Pharmaceuticals Limited (RDPL) to the Government of Rajasthan" received for comments was examined in Department of Public Enterprises and furnished comments thereon to obtain approval of Hon'ble Finance Minister.
- ii. Fourteen CGD/IMG/CMCDC meetings were held during the month.

- iii. Department of Public Enterprises furnished its comments on the following notes circulated for inter-ministerial consultations:
  - a. Note of Department of Social Justice and Empowerment for Expenditure Finance Committee (EFC) to consider continuance of the scheme and enhancement of authorized Share Capital of NSFDC from Rs. 1500 crore to Rs. 2500 crore.
  - b. Consultative paper of Department of Expenditure on Alternate Fund Flow Mechanism in respect of Centrally Sponsored Schemes using e-Kuber system of RBI.
- iv. Department of Public Enterprises participated in India-UK FTA negotiations intersessional in respect of chapter of SoEs.

## **5. Training programmes/workshops:**

- i) Department of Public Enterprises organised 2-day Induction & Capacity Building Workshop of Independent Directors (ID) in collaboration with Capacity Building Commission (CBC) & Indian Institute of Corporate Affairs (IICA) as knowledge partner. The programme was organized in two cohorts on 19-20<sup>th</sup> September, 2022 and 21-22 September, 2022 at India Habitat Centre, New-Delhi and was attended by 20 participants and 34 participants respectively.
- ii) Department of Public Enterprises in collaboration with IICA organized a two-day orientation programme on 26-27<sup>th</sup> September, 2022 at Jaipur, Rajasthan for Capacity Building of Government Directors from various administrative Ministries of CPSEs. 28 Government Nominee Directors from various administrative Ministries/Departments attended the programme.
- iii) Department of Public Enterprises conducted five training programmes and three workshops during the month which were attended by 230 executives of CPSEs/SLPEs.
- iv) Department of Public Enterprises in association with the Institute of Company Secretaries of India (ICSI) organized 2-days residential training programme for Company Secretaries of Central Public Sector Enterprises (CPSEs) during 22<sup>nd</sup> -23<sup>rd</sup> September, 2022 which was attended by 42 participants.

## **6. Matters related to procurement through GeM and MSMEs:**

- i) Financial Advisors of all administrative Ministries/Departments were requested to prepare annual action plan (2022-23) for procurement in respect of each of the CPSE's under their respective Ministry/Department separately for procurement from GeM and that from MSEs and to monitor the usage of TReDS platform by the CPSEs.
- ii) All CPSEs were apprised about the facility of 'Push Button Procurement' for small value procurements which has been introduced purely on experimental basis for one year by GeM.

**7. Memorandum of Understanding:**

D/o Public Enterprises has issued MoU for the year 2022-23 in respect of 98 CPSEs during the month of September, 2022.
