G.S.R. 1499(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Ministry of Heavy Industries and Public Enterprises, Department of Public Enterprises, Group A posts Recruitment Rules, 2014, namely :—

1. (1) These rules may be called the Ministry of Heavy Industries and Public Enterprises, Department of Public Enterprises, Group 'A' posts Recruitment (Amendment) Rules, 2017.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Ministry of Heavy Industries and Public Enterprises, Department of Public Enterprises, Group A posts Recruitment Rules, 2014,-
