- i. Must have retired from Central Government service at the level of Assistant or above.
- ii. The consultant proposed for engagement shall be well acquainted with the functioning of Central Government Ministries/Department.
- iii. The work profile and responsibility would be equivalent to that of an Assistant in Central Government.
- iv. They should possess experience in handling work related to (i) Library or (ii) Audit/Accounts/Budget.

 - i. The engagement shall be initially for a period of one year, or whenever regular incumbents are available whichever is earlier.

 - v. The consolidated consultancy fee would be Rs. 20,000/- (Rupees Twenty Thousand) only per month.
